#### PLACE OF DATA PROCESSING AND COMMUNICATION

The processing operations connected to the web services of this site take place at the aforesaid registered office of the Company and are carried out by the Company's personnel and/or by external persons in charge of duly appointed maintenance and updating operations. ### **TYPES OF DATA PROCESSED**

### **Navigation data**

The computer systems and software procedures used to operate this website acquire, during their normal operation, some personal data whose transmission is implicit in the use of Internet communication protocols.

This information is not collected in order to be linked with identified interested parties, but by its very nature could, through processing and association with data held by third parties, allow users to be identified.
