

**Subject: Information on the processing of personal data provided pursuant to Art. 13 Reg. 2016/679/EU.**

This is to inform you that our company processes your personal data. Processing shall be carried out in compliance with the criteria laid down in the European regulation on the protection of personal data, Reg. 2016/679/EU (hereinafter G.D.P.R.) and any other national legislation, measure or authorisation of the competent authority connected to it. According to the legislation, processing must be based on principles of fairness, lawfulness and transparency and the protection of your privacy and your rights.

**1) The data controller is Fromm Wrapping Systems Srl, in the person of its legal representative pro tempore, with registered office in **Viale del Lavoro, 21 - 37013 Caprino Veronese (VR)**, Tel: **045/2057300**, e-mail: **frommwrappingsystems@legalmail.it.****

**2) The data will be collected with your consent (according to Art. 6.1 letters. a) and f), G.D.P.R.) and will be used for the following purposes:**

- a. Enter the user/password assigned to register on the website and access the private area where you can view the Fromm Wrapping Systems Srl. content. Express consent will not be required for this purpose.
- b. View the material published in the price list and then order the sample shown. As this is indirect commercial marketing we require your express consent and any refusal will deny access to the site.

**3) Procedures:** personal data is processed by the owner and duly appointed personnel for the proper fulfilment of the purposes indicated in paragraph 2) by electronic means and paper files, as well as using security measures to ensure the confidentiality of personal data and to prevent undue access to unauthorized persons.

**4) Communication:** data may be communicated to internal and duly appointed external subjects in order to carry out activities on behalf of the data controller.

There is no provision for communication to **third countries** outside the EU and there is no provision for **dissemination** (e.g. social networks, websites, etc.). The data controller does not use automated processes, including **profiling**, to achieve the purposes set out in this statement.

**5) The Data Controller shall process personal data for the **time** necessary to fulfil the above purposes and in any case for no longer than 2 years from the termination of the relationship for the purposes indicated.**

**6) The interested party has **the right** to ask the data controller for access to his/her personal data or for its rectification or deletion or to limit any processing that concerns him/her, and has the right to oppose its processing and request its portability.**

The request can be made by email, fax or registered letter with subject: "**request by the interested party**" specifying in the request the right that the interested party wants to exercise (cancellation, rectification, portability, oblivion), together with a valid certified/e-mail address for delivery of the response.

The data controller or anyone appointed by same, will proceed to satisfy the request within 30 days from the date of receipt. If the answer is complex, the time may be extended to a further 30 days, subject to **timely notification** to the interested party.

If you deem it necessary to assert your rights, you have the right to make a complaint to the competent monitoring authority, being in this case the **National Privacy Guarantor**, with headquarters in Palazzo Monte Citorio 121, Rome, [garante@gpdp.it](mailto:garante@gpdp.it).
